

# **The 9/11 Attacks Remain an Unsolved Case of Mass Murder**

## **Appeal to Congress to withhold funding for increased forces in Afghanistan pending the outcome of a criminal investigation of the events of 9/11/2001.**

### **Why the Afghanistan War and Continued Occupation is Not Justified**

New revelations of forensic discovery make it clear that there was no justifiable reason for the attacks and continued occupation of Afghanistan. The failure of Congress to provide a valid investigation in the weeks following the 9/11/2001 attacks led to a war policy that incorrectly blamed Osama Bin Laden, Afghanistan, Al Qaeda and the Taliban for the attacks inside the United States. Conclusive evidence now establishes the Twin Towers and WTC 7 were demolished using controlled demolition – an operation that requires weeks of engineering preparation and robust access to each building by scores of demolition experts.

It's worth noting that the plethora of warnings allegedly bungled by the US intelligence agencies and ignored by the Whitehouse had described an incident of terrorist "attacks" of a spontaneous nature. But absent from any story of botched intelligence was a single warning that the Twin Towers and WTC7 had already been rigged with expertly placed explosives.

### **Multiple Failures to Investigate 9/11**

In a statement on **September 16, 2001** carried by *Al-Jazeera*, bin Laden had a categorically denied any involvement in the 9/11 operation. Days later, he repeated this denial during an interview with the Pakistani newspaper *Ummaut*. On November 3, 2001 *Al-Jazeera* released a third statement, in which bin Laden not only denied involvement but also accused the Bush administration of waging a "crusader war" against the Muslim world. None of these denials by Bin Laden were ever published in the US corporate media. In 2009 the FBI has still found no evidence to indict Bin Laden for 9/11.

**On September 23, 2001**, then Secretary of State, Colin Powell announced on *Meet the Press* that the government would soon release "white paper" detailing the evidence against bin Laden. But Powell was sent back on his word when the government found they could not publish the white paper because they had no hard facts. A Justice Department official said: *"There was not enough to make a sale."*

**In 2002** the White House prevented Congress from carrying out their obligation to investigate the events of 9/11. Later, pressure from the families of the murdered victims resulted in the formation of the so-called “9/11 Commission”. The final report was incomplete and later demonstrated to be fraudulent. In 2006 both the chair and co-chair admitted that the 9/11 Commission was "set up to fail". In 2009, John Farmer, senior counsel to the commission established in his book that the *government had lied* to the 9/11 Commission.

**Today there is little doubt the US has waged a mistaken war on Afghanistan when:**

1. The media failed to cover Bin Laden’s repeated claims of innocence.
2. The DOJ had no evidence to publish a white paper or to indict Osama Bin Laden.
3. The White House ordered Congress to stop their 9/11 investigation in 2002.
4. A 2006 admission that the 9/11 Commission was “set up to fail”
5. Senior Counsel, John Farmer established that the government lied to the 9/11 Commission in his 2009 book, THE GROUND TRUTH.

**Evidence Beyond Any Doubt:** The information presented here is considered to be of immediate interest to law enforcement and national security of the United States and conclusively demonstrates that pre-positioned explosives were ultimately responsible for the collapse of the Twin Towers and WTC7. These conclusions come from two bodies of independent research: (1) Evidence submitted to the FBI in November 2007 and (2) Peer-reviewed research authored by scientists, Niels Harrit and Stephen Jones et al. Each body of work stands alone is considered evidence **beyond a reasonable doubt** that undermines the government’s official story. Both works taken together elevate the scientific certainty for controlled demolition to: **“beyond any doubt”**.

In December, 2008 the Head of FBI's Domestic Counterterrorism Div., Michael J. Heimbach evaluated conclusive evidence presented by Architect, Richard Gage, AIA that demonstrates controlled demolition to be the only hypothesis that explains the near free-fall acceleration collapse of WTC7 and the Twin Towers. Director Heimbach responded in writing that Gage's multi-media presentation is, **“...backed by thorough research and analysis”**.

### **Controlled demolition acknowledged by WTC7 owner, Larry Silverstein**

Developer, Larry Silverstein has admitted he was involved in the decision to "pull" WTC7 in a 2006 PBS documentary "AMERICA REBUILDS". **CONCLUSION: Obstruction of Justice and Cover-up:** To date, neither Congress nor the Department of Justice has held a valid investigation of the events of 9/11/2001. When acted on appropriately, the scientific evidence presented here will strengthen national security while saving the debt and sacrifice of further blood and treasure by avoiding pursuit of individuals and groups that were never involved with the attacks inside the United States on 9/11/2001.
