



## FBI acknowledges evidence for Controlled Demolition presented by Richard Gage, AIA in his VIDEO: **9/11: BLUEPRINT FOR TRUTH**

On Nov. 7th, 2008 the FBI received a registered letter from Harold Saive, founder of Gators911Truth.org addressed to Director, Robert S. Mueller III. The letter included references to evidence contained in the Richard Gage, AIA video titled: "**9/11: BLUEPRINT FOR TRUTH**" in which Gage concludes the analysis of CONTROLLED DEMOLITION of three WTC skyscrapers is: "**...proof, beyond a reasonable doubt**".

The letter was submitted pursuant to Title 18 USC § 2382, "Crimes and Criminal Procedure", **Misprision of Treason**. This section applies to officials who have taken an oath to protect and defend the US Constitution. Saive expected that USC § 2382 could challenge the FBI to consider the evidence contained in Gage's presentation as "actionable intelligence". The penalty to a sworn official who violates "Misprision of Treason" by not reporting or acting on the evidence can lead to criminal prosecution, a prison term and fine.

**On Dec 22, 2008**, Saive received a letter of response from the head of FBI's Counterterrorism Div, - Michael J. Heimbach, thanking Saive for "offering to provide information to the United States Government". Heimbach goes on to assess Gage's presentation as "...backed by thorough research and analysis."
